After a long and very hot summer, Fall has finally arrived. While the last several months saw challenging conditions, our dedicated City employees continued their outstanding service to the people of Houston.

I want to begin by acknowledging Barbara Chelette, who served as a Board Trustee for 35 years and decided to leave the Board at the end of her term in July. Barbara was instrumental in moving HMEPS forward over more than three decades on the Board. I urge you to read more about her remarkable service on page 3. I am enormously grateful to Barbara and wish her the very best.

I am pleased to announce that long-time City of Houston employee, HMEPS employee and now retiree Carole Snyder is the Board's new elected Trustees' appointee. She will serve a three-year term. Welcome, Carole!

The Board's City appointees were all reappointed effective July 2023, for three-year terms. I look forward to their continued service. More information on the City appointees can be found on page 5.

I am proud to report that HMEPS has consistently had excellent investment performance. As reported by a widely recognized public fund database, as of June 30, 2023, HMEPS ranks in the top 1% for the past 3-, 5-, 15- and 25- year periods, and has a 10-year annualized return of 9.51%. Along with the system's historic 38.7% return in fiscal year 2021, HMEPS is on strong footing and participants should be confident that their benefits and pensions are secure.



HMEPS THANKS BARBARA CHELETTE FOR 35 YEARS OF OUTSTANDING BOARD SERVICE



Barbara Chelette, HMEPS' longest-serving Board Trustee, decided to conclude her 35 years of dedicated Board service when her term ended in July 2023.

Over more than three decades, Barbara served as both an elected employee Trustee and the elected Trustees' appointee on the HMEPS Board. She was an Officer of the Board in the position of Secretary for eleven years, served on all Board committees during her tenure, and chaired the Budget & Oversight Committee.

Barbara played a key role in several major changes at the System during her tenure. She was instrumental in the System hiring professional staff for benefit administration, accounting, and investments. These changes greatly upgraded the

System's internal operations, in particular, the hiring of in-house investment staff brought the System both increased returns and lower overall cost of investments by decreasing its reliance on outside contractors.

Barbara first joined the Board in 1989, and her commitment, knowledge, experience and insight helped to strengthen the pension system over many years. Barbara diligently represented the interests of tens of thousands of active and retired HMEPS participants throughout her Board service, through her leadership on committees and as Board Secretary. Barbara has been a role model, colleague and friend to the System's many Trustees, staff and participants.


Barbara's dedication to public service extended beyond HMEPS. She was elected by representatives from municipal pension systems across the State of Texas as a Director on the Board of the Texas Association of Public Employee Retirement Systems (TEXPERS), and served as TEXPERS Second Vice President. In addition, she served on the Supervisory Committee of the Board of Directors of the Houston Firefighters Federal Credit Union.

Barbara was a highly experienced and knowledgeable Board member who also understood firsthand the participant perspective as a long-time City of Houston employee. She retired as a Deputy Director from the Houston Fire Department after thirty-three years of service. As a Deputy Director, Barbara was responsible for the Finance and Administration Command, and directed the fiscal management of the department's \$200M+ annual budget, as well as its human resources functions. Her duties included procurement of all firefighter equipment and gear and overseeing the recruitment and hiring of all firefighters, the classified testing processes, eligibility lists, and all training in administrative procedures, affirmative action and human resources issues. For twenty years prior to her service as a Deputy Director, Barbara managed the Fire Department personnel budget, which constituted approximately 95% of the department's annual budget.

Barbara also was appointed by Mayor Bob Lanier to the Affirmative Action Advisory Committee, on which she served for several years. She holds the distinction as the first non-classified civilian, and the first woman in the history of the Houston Fire Department, to hold a position equivalent to that of Assistant Fire Chief on the Department's Executive Command Staff.

Council Appointee

Denise Castillo-Rhodes is the Chief Financial Officer of Texas Medical Center, where she oversees accounting, finance, revenue cycle, risk management, tax compliance, debt management, and the investment fund. Additionally, as a member of the executive leadership team, she is involved in the formation of the long-term strategic initiatives and planning, which includes the development of the collaborative bio-life science ecosystem. Ms. Castillo-Rhodes has served Texas Medical Center in this capacity since 2004.

Outside of her work, Ms. Castillo-Rhodes serves in leadership roles, including as the University of St. Thomas Vice-Chairman of the board of directors. In 2016, Ms. Castillo-Rhodes was

named Businesswoman of the Year and "Top 100 Women to Watch in America". She is a certified public accountant and is a member of the Texas Society of Certified Public Accountants and the American Institute of Public Accountants.

RMD Notice to Retirees with a DROP Balance

If you are a retiree with a DROP balance who is subject to the Required Minimum Distribution (RMD) rules (see Spring 2023 Pension Press at http://www.hmeps.org/publications.html), an HMEPS check in the amount of your RMD will be mailed to your mailing address of record by the end of October. Even if your monthly HMEPS benefit is paid by direct deposit, your RMD payment is paid by check sent to your mailing address on file at HMEPS.

Remember that you are responsible for ensuring that the correct RMD amount is distributed each year. Failing to take your RMD each year may result in significant IRS penalties being assessed against you. Failing to cash your RMD check may result in forfeiture of the payment amount.
